Please include where you took your CEU's or Fundamental B class and documentation from the Instructor. The list below includes the missing requirement(s). If you are in pending status please complete the missing ceu classes as soon as possible so that you may judge in 2012. Please note: there is a fine should you judge when in pending status. There is also a \$100.00 fine for missing fundamental b. If you are in pending status and you missed fundamental B class you cannot judge until that fine is paid. Thank you for staying current as a judge. Fulfilling your course requirements is in the best interest of our competitors, the ucwdc and yourself!

**To all event directors:** Only those judges listed as current may judge UCWDC sanctioned events. Should you wish to hire a pending judge please speak with them and be sure they are certified by the time your event is held.
