All examiners serve also as educators by which you can access training for the material included in the Dance Fundamentals Curriculum for both line and partner exams. All judge exams are based on this 10-point curriculum for which there are separate examinations for line and partner dancing. Each exam is made up of line-item topics that correspond to the Dance Fundamentals Curriculum, with each line-item tested separately by an examiner. The initial judge exam is the Entrance Exam. Once completed, the judge will move on to Apprentice Education and the Fundamental Exam. Completing the Fundamental Exam will constitute the first level of judging. When the judge completes the Journeyman Exam, he/she will achieve the second level of judging. When the judge completes the Master Exam, he/she will finally reach the highest level of judging.

Please contact the UCWDC approved educator of your choice and he/she will be happy to help you with direction, or your studies. The Curriculum is made up of three parts, the Core Concepts, Dance Mechanics (Fundamentals A), and Dance Artistry (Fundamentals B). Judge Certification offers separate classes in these parts. Each part is made up of salient topics, complete with sub-points. Our UCWDC educators often help people when training for an exam. In the event the topic you would like to cover is not within that educator's specialty, he/she will refer you to other educators who might be more helpful on that topic, or sub-point. Please refer to the Curriculum posted on the UCWDC website to see what topics need to be covered. Note you may also train with someone who is not an examiner, however, use caution to insure the person you choose has the most current and correct information. Please note if you study "in private lessons" with an examiner on an exam line-item topic, you may not then test on that topic with that same Examiner.
