



1. **Two Examinations Available:** We offer two genres of examination, Line Dance and Couples Dance. Line and Couples examinations are tested separately. However, if you have completed one exam (for ex. Line), and the same material is on the next exam (for ex. Partner,) you will not be tested a second time on the same material. We strongly encourage candidates who are knowledgeable in each skill sets to take both exams. Dual status is often looked for by event directors so they can easily place you on either line or partner panels.
2. **Who Should Apply?** It is important that you possess the knowledge and experience base needed to perform the duties of a UCWDC judge. We look for years of experience with regards to teaching/coaching country dance as well as strong personal competitive success in the UCWDC as an individual or through coaching. You must be able to detail your training and competitive placements. Please review the application as well as all requirements needed to decide if you have the proper qualifications. You must have a minimum of 5 years of experience to apply, but often much more is needed to attain the level of expertise needed for judging. The Application Committee will base their decision on your experience, and accomplishments, five years of experience is not a guarantee you will be accepted. The committee will also take into consideration professionalism in the UCWDC country community. Judges are ambassadors so professionalism on all fronts is especially important. Note: The UCWDC judge certification program is specifically designed to certify individuals who want to judge UCWDC competitions. (Please see the judge code of conduct found on the judge certification website).
3. **What if I am not involved in the UCWDC?** Often dancers from other genres want to apply to be admitted into the UCWDC judge certification program. It will be difficult to judge if you are not familiar with our sport. If you are interested, please immerse yourself by attending our competitions, learn the country dances, compete, and become present in our sport prior to applying to the UCWDC Judge Certification program.
4. **Age considerations:** Age matters because it is through experience that you gain the knowledge necessary to judge. We ask that you are at least 30 years of age, however if you are younger and possess the proper credentials, hold impressive competitive titles, and have proper competitive teaching/coaching experience you may request to apply, and you will be considered.
5. **When should I apply?** The judge certification committee will review applications at the spring and fall meeting. You must have all your paperwork and fees submitted for your application to be reviewed 30 days prior. Incomplete applications will be returned so please submit all material in one email.
6. **When do I know if I have been accepted?** Within 30 days of receiving your complete application, you will receive an email indicating if you have been accepted.
7. **Examination Descriptions:**
 - A. **Entrance examination:** There are 2 parts of the entrance examination.
 1. Submission of a short video with you demonstrating the dances you are being tested on. (You will receive detailed instructions). Master dancers may request to forgo the video if they have had as student in the top 5 of at Worlds in the Intermediate or Advanced Divisions. Since we are giving exams online and at events, the videos allow us to use music and will shorten the time of the exam as we will have seen the necessary material and can ask questions based on the video if needed.
An oral test that is based on the Curriculum and video: The Dances found on the UCWDC Judge Certification page.
 2. Upon successful completion of the test, you will be granted "Apprentice Status". Your name will appear on the judge pool roster as an "Apprentice". This means that you have completed the entrance exam and are in the process of completing the next level of testing while working on apprentice items.



3. The Entrance Exams is completed in 2 hours. You will take one half of the examination with one examiner and the other half with a 2nd examiner. You have 15 months to complete this exam (although we encourage you to complete the examination as soon as possible). These exams are available on-line or may be taken in person.

B. Fundamental Examination: This exam is taken after passing the entrance exam.

1. This exam will test the Newcomer/Novice Curriculum. (Qualifications to judge Newcomer/Novice).
2. You have 2 years to complete this section (although we encourage you to complete it as soon as possible).
3. This examination is 3 hours long, splitting between 2 examiners. Please note: if you are not able to pass a certain line item on the test you will be given provisions. This means you will need to re-study and re-take that portion of the test that you were not able to complete. Note: provision testing is not included in the exam fee. So please take the time to be prepared.
4. In addition to the examination, you will need to complete an "apprentice form" which covers judging concepts such as rules, mock judging, scoring and other important considerations.
5. Upon successful completion of the examination and the apprentice work, you will receive "Fundamental Status" and you may begin to judge. Fundamental Status certifies a judge to adjudicate newcomer and novice levels.

C. Journeyman Examination:

1. The Journeyman exam will test on the Intermediate/Advance Curriculum.
2. You have 2 years to complete this section (although we encourage you to complete the examination as soon as possible). Upon completion you will receive "Journeyman Status" for which you are then certified to judge newcomer through advanced levels.
3. This examination is 3 hours long, splitting between 2 examiners. Please note: if you are not able to pass a certain line item on the test you will be given provisions. This means you will need to re-study and re-take that portion of the test that you were not able to complete. There is an additional fee for provisional testing so please be prepared. Note: you must be a Journeyman judge to judge at the UCWDC World Championship.

D. Master Examination:

1. The highest level of Adjudicator is the Master Level Status. In order to test for this level, you must submit a current resume indicating current training you are receiving, your teaching and coaching status (include levels), competitive results for yourself or students (lists levels and placements) and how often you are judging. Please include all information that shows you are actively involved in the country DanceSport to the Vice President of Judge Certification.
2. The judge certification committee will then review this request and resume. Upon acceptance, you have 2 years to complete the examination. The examination is 4 hours long and must be administered by a minimum of 2 examiners. Once completed, you will hold Master Level Status.



Frequently Asked Questions

8. **How do I prepare for the examinations?** If you are applying to become a judge, you should already have the knowledge needed to pass the examinations. However, you will want to prepare such that you are able to easily describe, discuss and demonstrate all test material. Please go online and download the documents on the Judge Certification website, specifically the fundamental curriculum, methodology, feedback comments and the standards of the dances.
9. **Who should I study with?** You should study with those individuals who will assist you based on your learning style. Please see the official UCWDC Educators List on the UCWDC website. However, you may use current judges, or professionals of your choice. As you oversee your own training, we encourage you to study with various individuals so you have a well-rounded view of the material. It is important that during the examination you can easily discuss all points of the curriculum.
10. **Who will be my examiner(s)?** All examiners are listed on the UCWDC website. You choose 2 examiners for your examination. Testing is available online as well as in person.

Additional Information

11. **The application process:** Be sure to submit all required documents via email to judgecertification@ucwdc.org. Failure to submit all necessary documents may result in your application being reviewed at a future meeting. You must include: 1) a fully completed application sheet, 2) Resume 2) four letters of reference stating why you would be a good judge and endorse your knowledge and credentials, 3) a letter indicating why you want to judge, and 4) a photo of yourself (when the judge certification committee meets, it is helpful to see who is applying, and someone may not know your name but knows who you are). The \$ 50.00 application fee must be paid to the UCWDC when applying. If the fee is not paid by August 1st (for the Fall meeting) or January 15th (for the Spring meeting) to the treasurer@ucwdc.org, your application will not be reviewed until the next meeting.
12. **Paperwork:** Please be sure to keep all exam paperwork in good order. You are responsible for having the paperwork present for the examination. This is your only record that you have completed the various sections of the exam. Please be sure you always have a copy of the exam as you progress. We recommend storing an updated copy somewhere secure in case actual paper work gets lost.
13. **Additional requirements.** Judge certification requires all apprentices and judges to take 2 continuing education classes (CEU) each year. Fundamental judges must take a fundamental b course which focuses on the journeyman exam content. Upon receiving journeyman status, you will no longer need to take the fundamental b course, but will still be required to take the continuing education classes.

The UCWDC prides itself on having a professional and knowledgeable judge pool. Please be sure that you have the proper qualifications for certification. If you do possess them, we welcome and encourage you to complete the judge certification process and become a certified UCWDC Adjudicator!

Fees, Exam Duration and Test Deadlines

Application Review Fee: \$ 50.00 due upon submitting your Application
